West Zone Power Distribution Company Ltd. (WZPDCL) is engaged in distribution of electricity in the South Western part of Bangladesh (21 District & 20 Upazila Sadar), invites applications from Bangladeshi citizen for recruitment of **Managing Director** for the Company on contractual basis initially for a period of 2(two) years but renewable with the satisfactory performance. Job description, required qualification & experience and salary packages are described as under:

Job Description:

The Managing Director is the Chief Executive of the company reporting to the Board of Directors. Subject to the supervision and approval of the board, the Managing Director will be responsible for overall management, e.g. administration, corporate planning, business development and ensuring the compliances of law, rules and regulations and for good governance. He is also responsible for supervision of all technical, financial & welfare aspects, negotiation for project financing issues with donors/development partners and listing the company in the stock exchanges etc.

Qualification, Experiences and Age:

- 1) Candidates must be at least graduate in Electrical/Mechanical/ Civil Engineering or Masters in Finance/ Business Administration/ Management from any recognized university.
- 2) No third division/class at any stage of the academic career shall be acceptable. Candidates passed in the grading system must possess at least a CGPA 4.0 on a scale of 5.0 and a CGPA 3.0 on a scale of 4.0.
- 3) At least 25 (twenty five) years of works experience of which at least 5 years in senior management position.
- 4) At least he should serve as Chief Engineer/Addl. Chief Engineer in Power Sector.
- 5) At least 5 years experience in like generation/transmission/distribution utilities.
- 6) Must be able to demonstrate knowledge about relevant Govt. rules regulations.
- 7) Must be able to demonstrate in company law, labour law, TPM, TQM, Preventive Maintenance, Corporate Governance etc.
- 8) Must Demonstrate strong participatory leadership ability.
- 9) Must possess adequate knowledge in corporate Management.
- 10) Must have strong communication skill in Bengali & English (written & spoken) including working experience using computer.
- 11) Must have the ability to bring about change in organization culture.
- 12) Maximum age limit will be 60 (sixty) years as on the closing date of receiving of application.
